



# Arizona credit for solar energy devices

Does Arizona have a solar tax credit?

In addition to the federal solar tax credit, Arizona residents are eligible for a 25% state solar tax credit, property tax exemption and sales tax exemption on solar equipment. The Grand Canyon State offers a solar tax credit of 25% of your installation costs, up to a maximum of \$1,000.

How do solar incentives work in Arizona?

Arizonans can take advantage of the statewide tax credit, tax exemptions and local rebate programs on top of the 30% federal solar tax credit to dramatically reduce their total system cost. We've extensively researched all of the solar incentives in Arizona so you can understand how each one works and get the best deal on your solar system.

What technologies are eligible for Arizona tax credit?

The following technologies are eligible for Arizona tax credit: Photovoltaics, Solar Water Heat, Passive Solar Space Heat, Solar Space Heat, Wind, Solar Ovens, Solar Cooling, Solar Pool Heating, and Daylighting. Who is eligible for the solar energy credit in Arizona?

A1. An individual who is an Arizona resident who is not a dependent of another taxpayer is eligible to take the solar energy credit. Q2. What is the amount of the solar energy credit? A2. The solar energy credit is equal to 25 percent of the cost of the device.

What is a solar energy credit?

The credit is in lieu of any allowance for Arizona. A person who sells a solar energy device purposes for wear and tear of the device under in Arizona must furnish the buyer with a Internal Revenue Code § 167; 167.

Laws 2006, Chapter 333 established a solar energy device tax credit for solar energy devices installed in a taxpayer's trade or business located in this state for commercial or industrial purposes or any other non-residential applications through December 31, 2018. The credit is equal to ten percent of the installed cost of a solar energy

Residential Solar and Wind Energy Systems Tax Credit - Individual taxpayers who install a solar or wind energy device at their Arizona home are eligible for Arizona's solar energy credit. No matter how many energy devices are placed, a credit of up to \$1,000 is provided against the taxpayer's income tax for 25% of the cost of a solar or wind ...

Arizona's Solar Energy Credit is available to individual taxpayers who install a solar or wind energy device at the taxpayer's Arizona residence. The credit is allowed against the taxpayer's personal income tax in the amount of 25% of the cost of a solar or wind energy device, with a \$1,000 maximum allowable limit, regardless of the number of ...

In Arizona, residents can benefit from a sales tax exemption on solar energy devices and their installation, provided by the Arizona Department of Revenue.
