Does Austin Energy offer solar incentives?

Austin Energy offers two types of solar incentives for business customers installing solar systems: 1. Performance-Based Incentive (PBI) For larger systems, your business may be eligible to earn an additional credit on your monthly electricity bill for the power generated by your solar system. 2.

Does Austin Energy sell solar installations?

According to Carlos Cordova, Austin Energy's corporate communications manager, "Austin Energy does not sell solar installations". Utility employees do not make solar solicitations to customers. Only registered installers that have met the program requirements are authorized to promote the solar rebates.

Does Austin Energy offer a value of solar Bill credit?
