Is Berkshire Hathaway Energy a good investment?

My thesis is that Berkshire Hathaway Energy, aka BHE, is making appealing investments in wind and solar that are good for the planet. Parent company Berkshire Hathaway (NYSE: BRK.A) (NYSE: BRK.B) doesn't require dividends and they have a long-term view such that BHE has the flexibility to pursue many renewable investment opportunities.

Does Berkshire Hathaway own a utility company?

Berkshire Hathaway owns Berkshire Energy, a utility company. They can retain their cash flow within the company, unlike traditional utility companies that typically pay dividends to their investors.

What does BHE Renewables do?

BHE Renewables owns solar, wind, geothermal and hydroelectric projects that produce energy for both the wholesale market and for customers under long-term power agreements. By working to produce usable energy from noncarbon resources, these businesses offer energy alternatives and help to reduce the environmental impacts of energy creation.

Is Berkshire Energy a stock advisor?

Berkshire Energy is a utility subsidiary of Berkshire Hathaway. It used to be called MidAmerican and was changed to its current name in 2014.

Does Berkshire Hathaway reinvest?

Berkshire Hathaway, as the owner of Berkshire Energy, is not required to reinvest their cash flow. Instead, they can retain it within the company and reinvest more easily if needed for new projects, thanks to their ability to build up cash flow consistently.

Is Berkshire Hathaway's long-term plan paying off?

Berkshire Hathaway's long-term plan related to renewable energy is paying off.
