



# Can you ship lithium batteries through usps

Can I ship a battery via USPS?

Your batteries might be eligible for shipping via U.S. mail, but you need the right battery packaging to make those shipments compliant. You must follow USPS Packaging Instructions 9D strictly to prevent batteries from short-circuiting, overheating or catching fire.

Can I mail a lithium battery?

In the next section, we'll go over USPS limitations and requirements for mailing these batteries. The Postal Service allows limited quantities of lithium batteries to be mailed domestically (within the U.S.) as long as certain conditions are met. Here are the key rules and restrictions to be aware of:

Can You ship a lithium battery?

Lithium batteries are prohibited in international mail, and domestic air shipments have even stricter limitations. When in doubt, always check with USPS for the most current regulations. As The Toy Professor, I've shipped my fair share of battery-operated playthings over the years.

Can a lithium battery be mailed internationally?

2. Used, damaged, defective, or recalled lithium batteries and used damaged, or defective electronic devices containing lithium batteries are prohibited and may not be mailed internationally or to, from or between APO, FPO, or DPO locations under any circumstances.

How do I ship a battery?

Individual batteries can be shipped via Surface or Ground Transportation only (Max weight 5lbs). USPS has official instructions and guidelines for shipping batteries. ShipSaving helps you to highlight the following information:

Can a lithium battery be attached to a mailpiece?

Except for mailpieces containing button cell batteries properly installed in the equipment they are intended to operate, mailpieces containing mailable lithium metal or lithium-ion batteries must be rigid, sealed, and of adequate size, so the lithium battery mark can be affixed to the address side without the mark being folded.

As any shipper knows, sending lithium ion batteries is a process. In addition to following specific packaging regulations, you also can only use ground transportation services such as USPS Parcel Select Ground and UPS Ground. ... Under federal law, it is illegal to send these types of ammunition, domestically or internationally, via the U.S. Mail. Small arms ammunition poses a significant danger to Postal employees, equipment, and customers, and

When shipping through USPS, you can only send a lithium-ion battery up to 270Wh without full hazmat certification. So, if your eBike battery is above 270Wh, you have to fill out the necessary documentation and find a hazmat-certified shipper to pack and ship your eBike and its battery. ... You can ship a lithium-ion battery with 300Wh capacity ...

When shipping almost any battery, you must protect all terminals against short circuits that can result in fires. Protect terminals by completely covering them with an ... Every shipper of lithium batteries via air transport has the responsibility to comply with IATA 3.9.2.6.1(g) requirements as of ...

FedEx takes the transport of your shipment containing lithium batteries very seriously and complies with the International Air Transport Association (IATA) and International Civil Aviation Organization (ICAO) regulations for carrying such items as a carrier.

Lithium batteries (like the ones in cell phones, laptops, and electronics) pose significant risks of catching fire. Lithium batteries are mailable within certain guidelines; ... If your item is prohibited, you can't send it with USPS and need to find another solution. 3

Persons wishing to ship lithium batteries and electronic devices containing lithium batteries by mail should be aware that certain requirements must be met to ensure safety during transport. The easiest way to make sure that these requirements are met,

UPS Allows You to Ship Lithium Ion Batteries with Ground and Air Service. That means you won't be able to use any of their air-based domestic services, such as 3 Day Select, 2nd Day Air, and Next Day Air.

Shipments of lithium metal batteries, lithium metal batteries packed with equipment, and lithium metal batteries contained in equipment may be packaged in accordance with Section II IATA (Section II ICAO) packaging requirements provided that the metal or alloy cell content does not exceed more than 1g, and the aggregate lithium content does not ...

Lithium batteries are dangerous goods, and all of the regulatory requirements must be complied with, as set out in the Lithium Battery Shipping Regulations. In the United States, failure to comply with these regulations can result in a civil penalty of up to \$27,000 per offence (LBSR 1.3).

You may only mail lithium batteries: Meeting the conditions outlined in Schedule 2, Special Provision 34 of the Transportation of Dangerous Goods Regulations. Subject to the restrictions set out in the table below ; Please note: You aren't allowed to ship lithium batteries to any destination outside of Canada and the U.S.

A table in the Lithium Battery Shipping Regulations manual gives the precise weight of batteries per package on both cargo and passenger aircraft. All marks and labels must be clearly visible on the exterior of all packages and overpacks. Proper marking and labeling is required when shipping lithium batteries by air.
