Can I ship lithium batteries via USPS?

#1: Yes, you can ship lithium batteries via USPS. However ... There are currently six types of lithium batteries eligible for shipment, in varying domestic or international quantities, via USPS: Don't forget the new lithium battery marks that became mandatory this year!

Can I ship lithium batteries overseas?

For shipping lithium batteries with USPS overseas, you can ship a maximum of 4 cells or 2 batteries that are installed in the new or certified refurbished equipment or device it operates, without any lithium battery markings. However, individual batteries are prohibited from USPS international shipping.

Can a lithium battery be attached to a mailpiece?

Except for mailpieces containing button cell batteries properly installed in the equipment they are intended to operate, mailpieces containing mailable lithium metal or lithium-ion batteries must be rigid, sealed, and of adequate size, so the lithium battery mark can be affixed to the address side without the mark being folded.

Can a battery be shipped via USPS?

USPS battery shipping allows you to ship it under certain conditions, but there are still some types of batteries that cannot be shipped. The following introduces nonmailable and mailable situations: USPS has strict rules for shipping batteries, and one of the most critical factors is Watt hours (Wh).

How do I ship a lithium battery?

USPS has official instructions and guidelines for shipping batteries. ShipSaving helps you to highlight the following information: All packages containing lithium metal or lithium-ion batteries that can be mailed must be of sufficient size, sealed, and rigid. This ensures that the lithium battery mark can be affixed to the address without folding.

Did the postal service change the shipping standards for lithium batteries?

The Postal Service announced these revisions via a Federal Register notice titled "Revision to Mailing Standards for Lithium Batteries," which was published on July 26, 2017 (82 FR 34712-34715).

Lithium-ion batteries can potentially catch fire if damaged during transit, which is why there are many shipping restrictions. Are lithium batteries shipped fully charged? No, lithium-ion batteries cannot exceed 30% of their full capacity when shipping. Does it cost more to ...

However, when it comes to cell phones, lithium-ion batteries are installed within the equipment they power, ... When you ship with USPS, you can ship a phone with any air-based service, such as First Class Package. You just need to affix this special UN3481 label to the outside of your box, ...

However, others come equipped with rechargeable lithium ion battery packs. One example of a tool like this is an electric drill. That isn't necessarily a problem when it comes to sending them with USPS, but you should know that shipping packages with lithium ion batteries requires a different process than others.

If your laptop has a lithium battery, you have to use a special label that indicates that your package contains lithium batteries. You can get this label from a postal store or online. The label should have the words "Lithium Battery" and "UN 3481" on it, ...

**LITHIUM BATTERIES.** Lithium batteries power numerous electronics from cell phones, laptops, and tablets to wireless headphones, toys, and portable tools. What is not generally known is that these batteries are considered hazardous materials and remain highly regulated in transportation.

When shipping lithium batteries, a DGD or equivalent form is usually required. This form provides specific details about the hazardous materials being shipped, including their UN number, proper shipping name, class, packing group, and any special handling instructions. ... Yes, you can ship batteries through USPS, but you need to follow their ...

Lithium-ion batteries must also be properly packaged and labeled with the battery type, weight, and "Contains Lithium Ion Batteries" warning. Additionally, the drill itself should be properly packaged to prevent any damage during transit. When shipping, make sure to choose a service that offers tracking and insurance to protect your ...

If not, securely package your item using non-Priority Mail shipping materials (USPS does not permit the use of Priority Mail shipping materials to ship a Ground Advantage shipment) and attach your shipping label to the box. Once complete, drop off your package at USPS or schedule a free USPS pickup. To ship electronics containing or packed with a lithium battery:

United States Parcel Service (USPS) published a notice in the Federal Register that describes revisions to USPS Publication 52, Hazardous Restricted, and Perishable Mail. These revisions closely align USPS requirements for shipping lithium cells and batteries with those found in both the U.S. D.O.T. and international regulations.

Shipments of lithium metal batteries, lithium metal batteries packed with equipment, and lithium metal batteries contained in equipment may be packaged in accordance with Section II IATA (Section II ICAO) packaging requirements provided that the metal or alloy cell content does not exceed more than 1g, and the aggregate lithium content does not ...

Shipping Regulations When shipping lithium batteries, businesses must comply with U.S. Department of Transportation (DOT) standards and Pipeline and Hazardous Materials Safety Administration (PHMSA) standards for preparing shipments that contain lithium batteries.
