SolarCity was founded in 2006 by Musk's cousins, Peter and Lyndon Rive. It was backed by Musk who served as chairman of the board at both Tesla and SolarCity. A judge sided with Elon Musk in a court case brought by investors over Tesla's acquisition of SolarCity, which they claimed was pushed by Musk to bail out the solar installer.

SolarCity shareholders received 0.11 Tesla shares for each SolarCity share they owned.
