Is Europe a leader in residential energy storage?

While China and the US dominate the market, Europe leads in residential energy storage- and this is set to expand on the continent by nearly tenfold this decade. However, by 2023 Europe will give up its leadership position to the Americas, where there will be further investment in the residential segment.

Is the home storage market growing in Europe?

The market for home storage is growing at a record paceacross Europe. For example, in its latest market study for residential energy storage, Solar Power Europe calculates an increase in storage capacity of 71% (3.9 GWh) in the most likely scenario for the past year.

How much energy storage will Europe have in 2022?

Many European energy-storage markets are growing strongly, with 2.8 GW(3.3 GWh) of utility-scale energy storage newly deployed in 2022, giving an estimated total of more than 9 GWh. Looking forward, the International Energy Agency (IEA) expects global installed storage capacity to expand by 56% in the next 5 years to reach over 270 GW by 2026.

Which country has the largest residential storage market in Europe?

Overall, Germanyis expected to remain the biggest and most developed residential storage market in Europe over the next years. Our Medium Scenario estimates new additions of 5.95 GWh for 880,000 new units between 2021 and 2025.

How many new battery energy storage systems will be installed in Europe?

The latest analysis by SolarPower Europe shows that 17.2 gigawatt hours(GWh) of new battery energy storage systems (BESS) will be installed in Europe in 2023, supplying 1.7 million additional European households with electricity - an increase of 94% compared to 2022.

Europe's utility-scale energy storage systems (ESS) are on the rise, boasting a robust revenue model. The European large storage market is starting to shape up. The European energy storage industry has witnessed remarkable growth over the last decade, going from 9MW of project announcements in 2010 up to a total of 5,700MW in 2020 (year to date). Out of these projects, around 1.7GW are operational while the remaining 4GW are either announced or under construction (Figure 1) [1].

The scheme offers a maximum of AU\$6,000 assistance per household for the purchase of battery energy storage. Home storage systems are typically, but not always, paired with solar PV, and homeowners can get back between AU\$500 and AU\$600 per kilowatt hour of battery storage capacity purchased.
