Does Hawaiian Electric have solar & energy storage?

Hawaiian Electric, which serves all the islands except Kauai, is making significant changes to its rooftop solar and energy storage programs, which go into effect Monday. HECO's new program, Smart Renewable Energy (or Smart DER), was approved by the Public Utilities Commission.

Does Hawaii have solar power?

Hawaiian Electric ranks in the nation's top 10 electric utilities for solar power adoption by the Solar Electric Power Association. Solar water heating, PV, and concentrating solar power technologies have contributed to Hawaii becoming a national leader in solar power.
