



Kiribati equity energy storage project

What is Kiribati's energy consumption?

Primary energy demand. Kiribati's energy consumption, which is dominated by imported fossil fuels (52%) and coconut oil (42%), has been steadily increasing over the last few years. The residential sector is the largest consumer of energy, followed by land transport.

Does Kiribati need electricity?

As a small, remote island state, Kiribati is highly dependent on imported energy supply. Electricity is one of the government's largest expenditures. Yet the current fossil fuel-based power system is inadequate to meet future demand.

Why is electricity so expensive in Kiribati?

Of the 7,877 households in South Tarawa (44% of total households in Kiribati), 72.4% are connected to grid electricity. Access is largely for lighting, and that lighting is often insufficient, inefficient, and expensive. The high electricity cost has suppressed demand and has hindered growth in the commercial and tourism sectors.

How did Kiribati get a grant co-finance?

The Government 24 Project Administration Manual (accessible from the list of linked documents in Appendix 2). of Kiribati requested grant co-financing equivalent to \$3.7 million from the Strategic Climate Fund,²⁵ and \$2.0 million from the Government of New Zealand through the Ministry of Foreign Affairs and Trade, both to be administered by ADB.

Why is Kiribati so expensive?

Kiribati's remoteness from major markets and most resources leads to high import costs, while its low elevation - averaging only 2 meters above sea level - creates severe vulnerability to sea-level rise and other climate change impacts and natural hazards.

Can ADB improve aid effectiveness in Kiribati?

A development partners' agreement to improve aid effectiveness in Kiribati, which builds on the Paris Declaration, has been discussed among partners and with the government, and ADB will seek opportunities to promote its development. 19.

Why securing project finance for energy storage projects is challenging. It has traditionally been difficult to secure project finance for energy storage for two key reasons. Firstly, the nascent nature of energy storage technology means that fixed income lenders and senior debt providers are naturally risk averse.

A total of 311 applications were received for clean energy or decarbonisation projects after the call for submissions opened last summer. Of these, seven were selected to receive direct funding from a EUR1.1 billion budget and include hydrogen, carbon capture and storage, advanced solar cell manufacturing and other

technologies.

The development has consent for 51 energy storage containers and 42 transformers, with construction expected to start in late 2022. The utility-grade batteries will store electricity from the grid at times of low demand and high renewables, and export back to the grid at times of high demand and low renewables.

In coordination with the Ministry of National Assets, the programme aims to allocate energy storage capacity across four regions - Arica and Parinacota, Tarapaca, Antofagasta and Atacama.

Project owners Quinbrook and Primergy have put their 1.4GWh Gemini solar-plus-storage project in Nevada online, claiming it is the largest such project in the US. Gemini, in Clark County, pairs 690MWac/966MWdc of solar PV with a 380MW/1,400MWh battery energy storage system (BESS).

ESB Networks has announced that Ireland's electricity grid now has 1GW of energy storage available from different energy storage assets. This figure includes 731.5MW of battery energy storage system (BESS) projects and 292MW from Turlough Hill pumped storage power station - which is celebrating its 50th anniversary this year.

New Goldman Sachs-backed developer GridStor has acquired a portfolio of in-development battery storage projects in LA, California, from Upstream Energy, totalling 500MW/2,000MWh. The Portland-based grid-scale battery storage developer and operator announced the acquisition yesterday (26 October), saying the projects will come online ...

Utility Colbún has inaugurated a solar-plus-storage project with a 32MWh battery energy storage system in the Atacama region, the first of an 800MW deployment target. The Diego de Almagro project is a 330-hectare site comprising 470,000 solar panels totalling 230MW of power and a 8MW/32MWh BESS allowing for four hours of full power discharge.

Our sister site PV Tech reported a few days ago that Aquila Clean Energy, the group's platform in Europe, had raised financing for 2.6GW of clean energy projects in Southern Europe. Energy-Storage.news reached out to Aquila Capital for comment but had not received a reply at time of publication. However, the company did post a short comment ...

It also revealed that the concrete foundations have been completed for the firm's first gravity storage project in the US, in Georgia with Enel Green Power. Energy Vault now provides a range of energy storage solutions including battery storage and green hydrogen and is forecasting for US\$325-425 million in revenues this year.
