What batteries are allowed in carry-on luggage?

Batteries allowed in carry-on baggage include: Dry cell rechargeable batteries such as Nickel Metal Hydride (NiMH) and Nickel Cadmium (NiCad). For rechargeable lithium ion batteries; see next paragraph. Lithium ion batteries (a.k.a.: rechargeable lithium,lithium polymer,LIPO,secondary lithium).

What size lithium ion batteries can I carry on a plane?

With airline approval, devices can contain larger lithium ion batteries (101-160 watt hours per battery), but spares of this size are limited to two batteries in carry-on baggage only. This size covers the largest aftermarket extended-life laptop batteries and most lithium ion batteries for professional-grade audio/visual equipment.

Are lithium ion batteries allowed in checked luggage?

It's also important to keep in mind that lithium ion batteries are not allowed in checked luggage, so be sure to pack your portable charger in your carry-on bag. With these guidelines in mind, you can rest assured that your electronic devices will stay charged during your flight. Enjoy all the freedom that comes with travel!

Can you bring lithium batteries on a plane?

No,you cannot bring loose lithium batteries in your checked baggage. However,you can bring them in your carry-on bags as long as they are in the original packaging or have individual protection, such as tape or a plastic bag, to prevent them from short-circuiting. Can I bring rechargeable lithium batteries on a plane?

Should you travel with lithium batteries?

Traveling with lithium batteries has become commonplace as they power everything from smartphones to laptops, cameras, and even medical devices. In May 2023, the Federal Aviation Administration (FAA) revealed that lithium-ion battery fires had jumped 42 percent in the last five years.

Are batteries allowed in checked baggage?

Spare lithium metal and lithium ion/polymer batteries are prohibited in checked baggage--this includes external battery packs. Electronic cigarettes and vaporizers are also prohibited in checked baggage. "Checked baggage" includes bags checked at the gate or planeside. Q3. How do I determine the watt hours (Wh) rating of a battery? A3.

Baggage installed with non-removable batteries exceeding 0.3 g lithium metal or 2.7 Wh is forbidden for carriage. When the baggage is to be checked in, the lithium battery must be removed and carried in the cabin as a carry-on item. How to fly with rechargeable batteries. There are many kinds of rechargeable batteries, but two types, lithium

ion (Lion) and lithium polymer (Lipo) batteries, dominate the consumer electronics market, and are commonly used to power a range of devices, including computers, cameras, and even drones, that are commonly placed in checked or carry on baggage by passengers.

Baggage may contain items that are required to be carried with you onboard the aircraft. For example, spare lithium batteries for portable electronic devices and cigarette lighters must be removed from checked or gate-checked baggage and carried onboard the aircraft.

Smart bags with integrated lithium batteries for the purpose of charging an external device or to provide power to the wheels of the bag with non-removable lithium batteries will not be accepted as cabin baggage or Check in baggage, unless the device contains only lithium batteries not exceeding 0.3g of lithium metal batteries or 2.7Wh of lithium ion batteries.

Small lithium battery-powered vehicles are not accepted in either checked baggage or carry-on baggage due to safety concerns associated to the lithium batteries that power them. Prohibited vehicles include: hoverboards, AirBoards, electric skateboards, airwheels, mini-Segways, balance wheels, battery-assisted bikes and electric scooters.

Power restriction for lithium batteries: max. 160 Wh or 8 g LC per device. Power restriction for non-spillable wet batteries: ... The battery must be removed from the baggage. The removed battery must be carried in the cabin. You will find further information in the section "Power banks, replacement batteries and loose batteries". ...

Any lithium ion battery containing more than 160-watt hours is prohibited from carriage on all passenger aircraft. Lithium ion batteries installed in a personal electronic device can be transported as checked or carry-on baggage. Lithium ion batteries not installed in a device (spares) must be in carry-on baggage and no more than two (2) spares ...

If you can easily remove the lithium battery/power bank, the Smart Bag is permitted for carriage, subject to the following conditions: Lithium battery/power banks up to and including 100Wh are acceptable for carriage. Lithium battery/power banks of more than 100Wh up to 160Wh, please see the information in the lithium batteries section for ...

Lithium metal batteries:the lithium metal content must not exceed 2 g. Each person is limited to a maximum of 15 PED and limited to a maximum of 20 spare batteries. With operator approval, no more than 2 lithium ion batteries with a watt-hour rating exceeding 100 Wh but not exceeding 160 Wh are permitted in carry-on

baggage only for each passenger.

If the battery is a spare and not in the equipment, you must carry it in your carry-on baggage only. Lithium ion batteries 160Wh and over. You can"t carry lithium batteries rated at 160Wh or more unless they"re for wheelchairs and other mobility aids. Read more about wheelchairs and mobility aids with non-spillable batteries on flights. Lithium batteries are commonly used in electronic devices and can pose safety risks if mishandled or damaged. For this reason, there are restrictions on the transportation of certain lithium batteries in checked luggage: Spare Lithium Batteries. Spare lithium batteries (those not installed in a device) aren"t allowed in checked luggage.

As baggage powered by lithium batteries typically exceed 7kg in weight, please either check in the baggage or ensure the baggage is within the 7kg cabin baggage allowance. All transmitting functions (example: Bluetooth, Wi-Fi) must comply with the PED restrictions in the onboard Passenger Safety Information Card.

Smart Luggage, Self-Propelled Luggage, Self-Riding, eBags, etc In the interest of safety for our guests and employees, only "Smart bags" (luggage with charging devices or use a lithium battery powered electric motor) with batteries/power banks that can be removed without the use of a tool (e.g. push button, connected to the bag via USB or similar connection, or ...

Prevent short circuits by protecting battery terminals. This can be done with the manufacturer"s packaging or by covering with tape and placing in a separate bag. Store spare batteries in carry-on bags. Lithium-ion batteries can"t exceed 100 watt hours. Lithium metal batteries can"t exceed 2g. If you"re unsure about the battery, don"t ...

For a lithium metal battery, lithium content cannot be more than 2 grams per battery; For lithium-ion batteries, a maximum of 2, not exceeding 160 Wh each, are allowed in carry-on bag with airline approval; Traveling with lithium batteries Opens another site in a new window that may not meet accessibility guidelines. Example. Portable ...

I have been using an Anker PowerCore 20000 for a while now. This works with most devices, can charge an iPhone over 5 times, and is allowed in your carry-on bag. With your airline's approval, you can take devices that contain larger lithium-ion batteries (101-160 watt-hours per battery).

Spare (uninstalled) lithium ion and lithium metal batteries, including power banks and cell phone battery charging cases, must be carried in carry-on baggage only. With airline approval, passengers may also carry up

to two spare larger lithium ion batteries (101-160 Wh) or lithium metal batteries (2-8 grams).

Baggage Policy for Smart Baggage with Lithium (Lithium-Ion) Batteries: Non-removable lithium batteries: Batteries containing less than 0.3 g of lithium or with a capacity of under 2.7 Watt-hours, such as button cells, may be checked in or carried onboard. If the smart baggage is checked in, electronic devices installed on the baggage must be ...

Baggage equipped with lithium batteries must be carried as carry-on baggage unless the batteries are removed from the baggage. The exception to this is if the smart luggage contains lithium metal batteries with a lithium content not exceeding 0.3 grams or lithium ion batteries with a watt-hour rating not exceeding 2.7 Wh.

This covers typical dry cell batteries, lithium metal, and lithium ion batteries for consumer electronics (AA, AAA, C, D, button cell, camera batteries, laptop batteries, etc.) Spare (uninstalled) lithium metal and lithium ion batteries are always prohibited in checked baggage and must be placed in carry-on.

For companies that only ship lithium batteries, or products packaged with or containing lithium batteries is it more appropriate to take the Shipping Lithium Batteries by Air course to get a comprehensive look at how to ship lithium batteries and how to properly meet the requirements set out in the IATA Dangerous Goods Regulations .
