How many battery storage projects were awarded a contract?

Of the 6,124.249MW of capacity that entered the auction,94.42% was awarded an agreement. Battery storage projects totalling 627MWwere awarded contracts in the UK's 2023-24 Capacity Market auction yesterday (14 February).

What percentage of power plants are battery energy storage projects?

Battery energy storage projects accounted for 10.9% of the total awarded capacity, followed by 2.6 GW of gas-fired power plants and 1.4 GW of nuclear capacity. About four-fifths of the capacity procured in the auction across 269 capacity market units (CMU) was from existing power assets, the auction results showed.

Which battery projects are winning the Ngeso auction?

According to provisional auction results released by NGESO, almost half of the winning battery projects propose one-hour duration systems, while about 40% are for two-hour facilities. The list of winning schemes includes Zenobe, Gresham House, Harmony Energy, Pivot Power and SUSI Storage, among others.
