Renewable Energy Supply. Ireland's energy supply remains heavily dependent on imported fossil fuels. In 2023, 82.6% of Ireland's energy came from fossil fuels. Ireland set a record high of 23.38 TWh in renewable energy use across electricity, transport, and heat for 2023. Ireland's use of renewables in 2023 helped avoid 7.4 MtCO2.
