The large-scale grid-connection of wind power has brought new challenges to safe and stable operation of the power system, mainly due to the fluctuation and randomness wind power output (Yuan et al., 2018, Yang Li et al., 2019). To mitigate the impact of new energy sources on the grid, it is effective to incorporate a proportion of energy storage within wind farms.

The EESS is composed of battery, converter and control system. In order to meet the demand for large capacity, energy storage power stations use a large number of single batteries in series or in parallel, which makes it easy to cause thermal runaway of batteries, which poses a serious threat to the safety of energy storage power stations.

To mitigate lithium-ion battery fire risks, implement strict manufacturing standards, enhance consumer education on safe usage, and establish clear disposal guidelines.
