Is there a solar tax credit available in Indiana?

Indiana is a state that offers solar tax credits and incentives. The calculator above will show you the value of all incentives your home is eligible for. You can get a solar tax credit in Indiana. However, Indiana is set to phase out net metering, a rule that makes your utility credit you for all the power you produce but aren't able to use onsite.

#### How do I get a solar tax exemption in Indiana?

To do this, you have to complete Form 5695. Most of Indiana's solar incentives are intended for nonresidential use. The state offers a property tax exemption for residents using solar energy systems, though. The program subtracts the property value added by a solar energy system for the purposes of calculating property taxes.

#### Are solar panels tax deductible in Indiana?

In Indiana, there are no tax rebates for people who install solar panels on their homes. However, the state offers tax exemptions to make solar power more attractive. You are 100% exempt from all property taxes associated with the increase in home value caused by installing a solar power system.

#### Are solar panels a good investment in Indiana?

Solar batteries paired with solar panels can make good financial sense in Indiana. It boosts your energy independence and provides backup power during an outage, and it helps you keep more of your own (free) solar power rather than letting the utility company take it at a steep discount. Utility companies in Indiana--including NIPSCO,Indiana Michigan Power,AES,other electric co-ops,and municipal providers--do offer solar buyback programsthrough the state's Excess Distributed Generation (EDG) policy. Solar panel systems above 10 kW are credited with between \$0.13 and \$0.15.5 Availability is limited. The average property tax in Indiana is 0.75%: Indiana solar sales tax exemption: In Indiana, most components of a solar panel system are exempt from the 7% sales tax.
