This solar incentive initiative provides a fixed rate per kilowatt hour (kWh) of solar energy produced for ten years, paid by the State of Massachusetts to Eversource National Grid and its customers. The rate varies based on location and utility, ranging from 19 to 31 cents per kWh for systems under 25 kilowatts (kW).
