In total, analysts anticipate a 25 percent decline in residential solar installations this year compared to 2019, according to the Solar Energy Industries Association.

Sunrun and Vivint Solar are hosting a joint conference call for analysts, investors and media to discuss the definitive transaction agreement at 8:30 a.m.Eastern time on Tuesday, July 7,2020.

What happened to Sunrun and Vivint?

Sunrun's stock closed up more than 22 percent, and Vivint's closed up about 38 percent. Sunrun has focused on financing and installing solar panels and batteries rather than on producing those products itself(manufacturing), as stated by Ms. Jurich in an interview with The New York Times in 2018.

Sunrun Inc. on Oct. 8 completed its acquisition of Vivint Solar Inc., creating a combined residential solar company with an enterprise value of about \$22 billion and 3 GW of solar energy capacity. Under the all-stock transaction, Vivint Solar stockholders received 0.55 share of Sunrun common stock for each share held immediately prior to the ...
